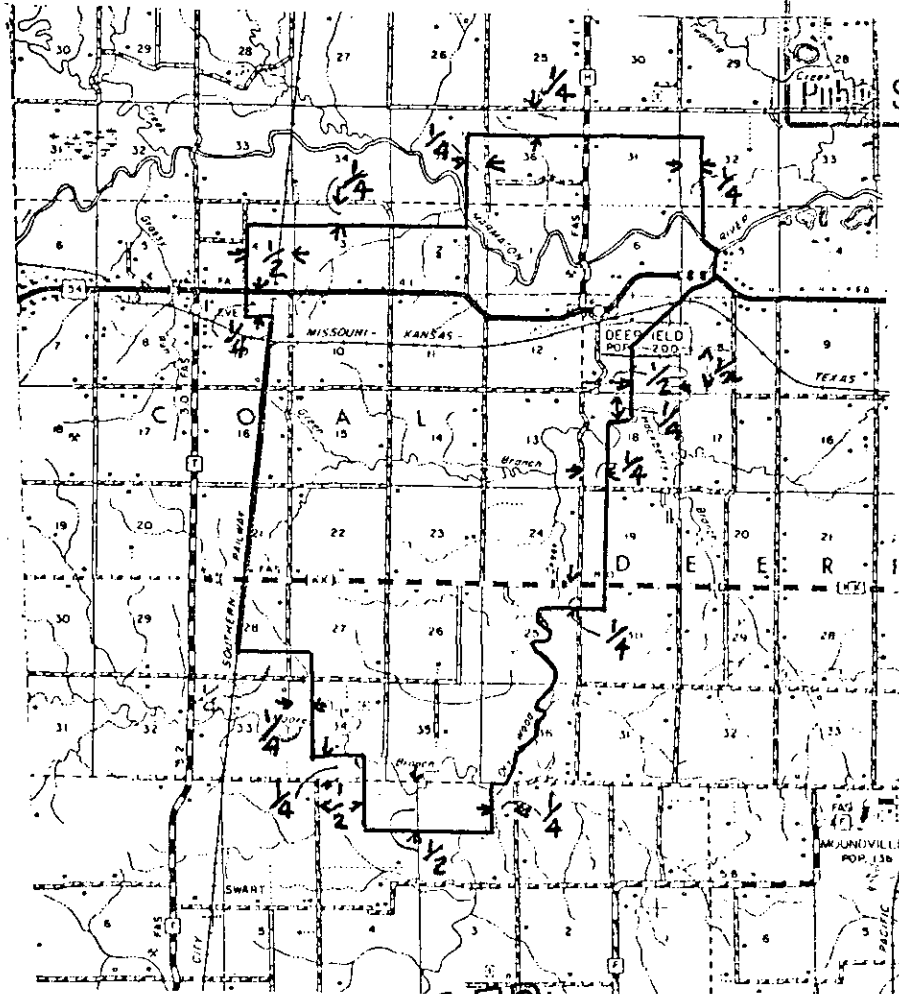

- B. The Company reserves the right to change the customer's telephone number or the central office associated with such number, or both, as may be required for the proper conduct of its business.

18. Directories

- A. The Company will furnish to its customers, without charge, its directory as necessary for the efficient use of the service.
- B. Directories regularly furnished to customers shall remain the property of the Company.
- C. No liability for damages arising from errors in or omissions of directory listings, or listings obtained from the "Information Operator" shall be attached to the Company.

19. Customer Service - Use of

- A. Customer telephone service, as distinguished from public and semi-public telephone service, is furnished only for use by the customer, his family, employees or business associates, or persons residing in the customer's household, except as the use of the service may be extended to joint users or to persons temporarily subleasing a customer's residential premises. The Company has the right to refuse to install customer service or to permit such service to remain on premises of a public or semi-public character when the station is so located that the public in general, or patrons of the customer may make use of the service. At such locations, however, customer service may be installed, provided the instrument is so located that it is not accessible for public use.

20. Rural Line Service

A. New cable extensions required for furnishing rural line service will be constructed along public highways by Public Telephone Company under the following conditions:

1. An allowance of 1/4 mile route measurement per applicant will be made for such cable extensions without the application of a construction charge.
2. For the construction in excess of the allowance stated in Paragraph (1) above, applicants for service are required to pay a construction charge based upon the estimated cable and construction costs involved.

B. Construction charges are payable at the time the application for service is signed or when the account is rendered, at the option of the telephone company. A deposit on construction charges may be required before construction work is started.

21. Party-Line Service - Use of

A. Applications for party-line service are accepted by the Company with the understanding that each customer will so use the service as not to interfere with an equitable proportionate use of the service by the other customers on the same line. When the duration or number of messages sent or received by a party-line customer is so great as to prevent an equitable proportionate use of the line by other customers on the line, the Company shall have the right to require the customer to contract for a higher grade of service, or to discontinue the service of the customer in question. The Company reserves the right to limit the continuous use of a party-line for a local message to five minutes.
