



that any such action is appropriate, Staff may file a formal complaint or other appropriate pleading within a new file to institute contested case procedures.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Staff shall undertake an investigation of the condition of SKM's water and sewer assets, including compliance with the disposition agreement in Case No. SR-2022-0239.
2. Staff shall file a status report no later than July 30, 2026, indicating when it expects to file an investigation report and recommendations.
3. This order shall be effective when issued.
