MOTION TO CONSOLIDATE

Comes now Missouri-American Water Company (MAWC or Company), and, as its Motion to Consolidate, states as follows to the Missouri Public Service Commission (Commission):

1. MAWC has filed with the Commission tariff sheets and direct testimony seeking a general rate increase for both its water and sewer operations. Two case numbers have resulted from these filings (WR-2026-0304 and SR-2026-0305).

2. The subject water and sewer operations are owned and operated by the same entity (MAWC) and have common offices, personnel and overheads.

3. Accordingly, there are common questions of law and fact in the above-referenced cases and the consolidation of Cases Nos. WR-2026-0304 and SR-2026-0305 would be administratively expedient in that it would simplify the filings to be made by MAWC and the other parties to these matters.

4. The Commission has stated, "Commission Rule 20 CSR 4240-2.110(3) permits the consolidation of pending actions that involve related questions of law or fact."¹

WHEREFORE, MAWC requests a Commission order consolidating Cases Nos. WR-2026-

0304 and SR-2026-0305, with Case No. WR-2026-0304 being the lead case.
