## ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE AND DIRECTING STAFF RECOMMENDATION

Effective Date: November 27, 2012

On November 26, 2012, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), submitted an application and tariff designed to implement an adjustment to its Fuel and Purchased Power Adjustment Clause. The submitted tariff bears an effective date of January 25, 2013.

Pursuant to Commission Rule 4 CSR 240-20.090(4), the Commission's Staff shall submit a recommendation regarding the proposed adjustment no later than 30 days after it's filing. No later than 60 days after receiving the proposed adjustment, the Commission must : (1) enter an interim rate adjustment; or (2) approve or reject the tariff as submitted; or (3) allow the tariff to go into effect by operation of law. Consequently, the Commission shall issue notice, set an intervention deadline, and direct its Staff to file a recommendation.

Commission Rule 4 CSR 240-3.161(10) provides that parties to the rate case in which the Commission established Ameren Missouri's fuel adjustment clause are automatically parties to this tariff case, without the necessity of having to apply for intervention. The Commission therefore acknowledges that the parties to File No. ER-2008-0318 (the file in which Ameren Missouri's Rider FAC was first approved) are parties to this case, and will direct its Data Center to add those parties to the service list. The Data Center will also be directed

to send notice of this order to the parties in File Nos. ER-2010-0036 and ER-2011-0028 (the files in which Ameren Missouri's initial Rider FAC was reauthorized with modifications).

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall serve a copy of this order upon the parties to File No, ER-2008-0318, ER-2010-0036 and ER-2011-0028.
2. The Commission's Data Center shall add all parties to File Nos. ER-2008-0318, ER-2010-0036 and ER-2011-0028 to the service list for this case.
3. Any person or entity wishing to intervene shall file an application to intervene no later than December 7, 2012, with:

4. The Staff of the Missouri Public Service Commission shall, no later than December 26, 2012, file a recommendation regarding its examination and analysis of Ameren Missouri's application.
