## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING DEADLINE FOR RESPONSES

Issue Date: July 16, 2026

Effective Date: July 16, 2026

On July 16, 2026, Missouri-American Water Company (MAWC) filed tariff sheets to implement the WSIRAs approved by the Commission earlier on that date. The tariff sheets, Tracking Nos. JW-2027-0007 and JS-2027-0008, bear an effective date of August 15, 2026.

The Commission will direct its Staff to file a recommendation regarding the tariff sheets and will set a deadline for responses to the tariff sheets filing.

### THE COMMISSION ORDERS THAT:

1. Staff shall review the tariff sheets filed by MAWC, assigned Tracking Nos. JW-2027-0007 and JS-2027-0008, and file a recommendation no later than July 24, 2026.
2. Any responses to the tariff sheets shall be filed no later than July 24, 2026.
3. This order shall be effective when issued.
