**ORDER DIRECTING RESPONSES
AND ISSUING A PRELIMINARY PROTECTIVE ORDER**

On July 21, 2026, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed its *Motion for Protective Order and for Expedited Treatment* (Motion) requesting a Protective Order concerning disclosure of its confidential and highly-confidential information through unsecured or generative artificial intelligence (AI) tools, platforms, systems, or similar technology. Evergy Missouri West requested expedited treatment of its motion.

At its core, the Motion seeks to prohibit any party, counsel, or their agents to whom confidential information is disclosed from inputting, uploading, submitting, or otherwise introducing such information into any unsecured or generative AI Tool (e.g. standard ChatGPT, Claude, Gemini, or similar platforms), including, but not limited to, the use of AI meeting note takers.

The Commission will set a time for responses and will then consider those responses in making a determination on the Motion. While that process unfolds, the Commission will issue a preliminary protective order.

Commission Rule 20 CSR 4240-2.135(4) provides that while a motion seeking expanded protection of confidential information is pending, the disclosing party will be afforded the protection sought. Therefore, the Commission will issue a preliminary protective order pending responses from parties and a determination by the Commission regarding the Motion.

THE COMMISSION ORDERS THAT:

1. Responses to Every Missouri West's Motion shall be filed no later than August 7, 2026.
2. Every Missouri West's request for a protective order is preliminarily granted. No party, counsel, or their agents to whom confidential information is disclosed shall input, upload, submit, or otherwise introduce such information into any unsecured or generative AI Tool (e.g. standard ChatGPT, Claude, Gemini, or similar platforms), including, but not limited to, the use of AI meeting note takers.
3. This order shall be effective when issued.
