On July 1, 2026,¹ Spire Missouri Inc. (Spire Missouri) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets, assigned Tracking No. JG-2027-0003. On July 30, the Staff of the Commission (Staff) filed its recommendation. Staff recommended that the Commission reject the tariff sheet revisions.

The Commission will order a response from Spire Missouri.²

THE COMMISSION ORDERS THAT:

1. No later than August 10, 2026, Spire Missouri shall file a response to Staff’s Recommendation.
2. This order is effective when issued.

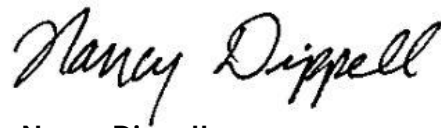
