ORDER DIRECTING SUBMISSION OF SUBSTITUTE TARIFF SHEETS, ORDERING A STAFF RECOMMENDATION, AND SETTING TIME FOR OTHER PARTY'S RESPONSES

Effective Date: July 31, 2026

On July 1, 2026,¹ Spire Missouri Inc. (Spire Missouri) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets, assigned Tracking No. JG-2027-0003. The tariff sheets bear a September 1, 2026, effective date.

On July 29, the Staff of the Commission (Staff) filed its recommendation. The recommendation noted that several adjustments to the tariff sheets were necessary. Staff requested that the Commission reject the submitted tariff sheets and order Spire to file corrected tariff sheets.

On July 30, Spire Missouri filed its *Response to Staff Recommendation* (Response) in which it stated that it agreed with the adjustments recommended by Staff. The Response included attached specimen tariff sheets consistent with Staff's recommendation but did not submit substitute tariff sheets. Spire Missouri requested that the Commission reject the submitted tariff sheets and order it to file corrected tariff sheets.

As both Staff and Spire Missouri request, the Commission will order Spire Missouri to

submit substitute tariff sheets in compliance with the proposed adjustments.²

THE COMMISSION ORDERS THAT:

1. No later than August 4, 2026, Spire Missouri shall file substitute tariff sheets for Tracking No. JG-2027-0003 consistent with Staff's recommendation.
2. No later than August 10, 2026, Staff shall file a recommendation regarding the substitute tariff sheets for Tracking No. JG-2027-0003.
3. Any other responses regarding the substitute tariff sheets for Tracking No. JG-2027-0003 shall be filed no later than August 14, 2026.
4. This order shall be effective upon issuance.
