On behalf of Timber Creek Sewer Company (“TCSC” or “Company”), I am providing herewith to the Missouri Public Service Commission (“Commission”) for filing certain sewer tariff sheets in electronic form. The proposed tariff sheets bear a date of issue of July 31, 2026, and an effective date of August 30, 2026.

These tariff sheets are being filed pursuant to and in conformity with the *Nonunanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request* (Disposition Agreement) filed this date in Case No. SR-2026-0093.

The P.S.C. MO No. 3 tariff book is designed to replace TCSC’s current P.S.C. MO No. 2.

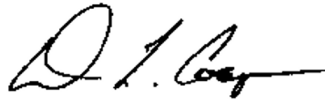
