Re: Notice of Adoption of “GoNetspeed” Fictitious Name by CRC Communications, LLC, Otelco Mid-Missouri LLC, and Otelco Telecommunications LLC

Dear Judge Dippell:

Pursuant to 20 CSR 4240-28.011(2), CRC Communications, LLC; Otelco Mid-Missouri LLC; and Otelco Telecommunications LLC (collectively, “Otelco Companies”) respectfully request that the Missouri Public Service Commission (“Commission”) acknowledge their adoption of the GoNetspeed fictitious name. The Otelco Companies are in good standing with the Missouri Secretary of State, in compliance with the Commission’s Annual Report requirements, and current with their applicable Missouri USF and Commission assessments. The Otelco Companies have reviewed their contacts on the Commission’s electronic filing and information system (EFIS), and they have been updated as needed.

Otelco Mid-Missouri LLC is an Eligible Telecommunications Carrier (ETC) and will continue to comply with all applicable laws and rules relating to the ETC designation. Also, please note that CRC Communications, LLC was issued an IVoIP Registration in Case No. DA-2019-0134, and Otelco Telecommunications, LLC was issued an IVoIP Registration in Case No. DA-2011-0017. Otelco Mid-Missouri LLC was issued Video Service Authority in Case No. KA-2012-0260.

Evidence of the fictitious name registration of GoNetspeed is included as Attachment A. A copy of the notice informing customers of the name change is included as Attachment B. A copy of the tariff adoption notices that were filed concurrently with this notice reflecting the new name are included as Attachment C.
