ORDER GRANTING APPLICATIONS TO INTERVENE

On July 1, 2026, Missouri-American Water Company (Missouri-American) filed tariff sheets designed to initiate a general rate case. Consumers Council of Missouri, Midwest Energy Consumers Group, Triumph Foods LLC, Public Water Supply District No. 1 of Andrew County, Public Water Supply District No. 2 of Andrew County, Public Water Supply District No. 1 of DeKalb County, Public Water Supply District of No 1 of Buchanan County, Great Northwest Wholesale Water Commission, and the City of Riverside Missouri filed timely applications to intervene. Ten days have elapsed, and no party has objected to these applications to intervene.¹

Commission Rule 20 CSR 4240 2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The applications satisfy the requirements of Commission Rule 20 CSR 4240-2.075 and serve the public interest. The Commission will grant these applications to intervene.

¹ Commission rule 20 CSR 4240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.

1. The applications to intervene filed by Consumers Council of Missouri, Midwest Energy Consumers Group, Triumph Foods LLC, Public Water Supply District No. 1 of Andrew County, Public Water Supply District No. 2 of Andrew County, Public Water Supply District No. 1 of DeKalb County, Public Water Supply District of No 1 of Buchanan County, Great Northwest Wholesale Water Commission, and the City of Riverside are granted.
2. This order is effective when issued.
