ORDER DIRECTING STAFF RECOMMENDATION ON COMPLIANCE TARIFF AND SHORTENING TIME FOR RESPONSES

On May 19, 2026, Spire Missouri Inc. d/b/a Spire filed an application to change its Infrastructure System Replacement Surcharge (ISRS). On August 26, 2026, the Commission issued its *Order Approving Infrastructure System Replacement Surcharge* (Order) rejecting the previously filed tariff sheet and authorizing Spire to submit a tariff sheet in compliance with the Order.

On August 27, 2026, Spire filed a tariff sheet purported to be in compliance with the Order. The submitted tariff sheet carries an effective date of September 25, 2026, and was assigned Tracking No. JG-2027-0029. Spire requested expedited treatment to permit the tariff sheet to become effective on September 7, 2026.

The Commission will direct the Staff of the Commission (Staff) to file an expedited recommendation as to whether the tariff sheets comply with the Commission's Order. The Commission will also shorten the time for other responses.¹

2. Any other responses shall be filed on or before September 2, 2026.

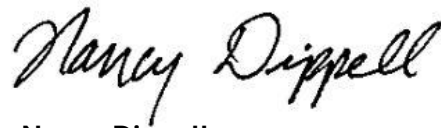
