MOTION TO AMEND PROCEDURAL SCHEDULE

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Company” or “Ameren Missouri”), with the concurrence of all parties, and hereby and moves for the Missouri Public Service Commission (“Commission”) to amend its procedural schedule ordered July 8, 2026, to extend the time for filing the List of Issues to allow additional time for settlement discussions. For its motion, Ameren Missouri respectfully states as follows:

1. On July 8, 2026, the Commission issued its *Order Setting Procedural Schedule* ("Order"). The *Order* established, among other things, September 17, 2026, for the filing of the List of Issues.

2. Ameren Missouri, the Staff of the Missouri Public Service Commission ("Staff"), and Renew Missouri have reached an agreement in principle resolving all their issues in this matter.

3. Ameren Missouri and the Office of the Public Counsel ("OPC") are currently discussing settlement terms and believe an extension of the time to file the List of Issues will aid in furthering the discussions.

4. Ameren Missouri has discussed with the parties an extension for the date for filing the List of Issues until September 21, 2026. All parties support this request.

5. No other modifications to the procedural schedule are requested at this time.

WHEREFORE, Ameren Missouri respectfully requests that the Commission modify the procedural schedule and extend the date for filing the List of Issues until September 21, 2026.
