**EVERGY MISSOURI METRO'S NOTICE OF ERRATA
TO TRUE-UP DIRECT OF WITNESS HSIN FOO**

COME NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro ("EMM" or the "Company"), by and through their counsel and, for their *Notice of Errata* ("Errata"), states to the Missouri Public Service Commission ("Commission") as follows:

1. On September 10, 2026, the Company filed true-up direct testimony of Company witness Hsin Foo (the "Testimony") in this docket.

2. A correction to the Testimony needs to be made at p. 3 lns. 18-21, as follows:

Q: What ~~W~~ were there ~~any~~ changes in load requirements ~~reflected~~ in the true-up filing?

A: ~~Yes.~~ As ~~discussed~~ contained in the surrebuttal workpapers provided by Company witness Mr. Bass, net system input increased by approximately three percent relative to the net system input in the Company's production cost model in direct filing. The change for large load customers is explained in my workpapers.
