Comes now the Missouri Industrial Energy Consumers (MIEC) and for its Response to Ameren Missouri's Motion to Compel Compliance with Order Resolving Issues Presented at Discovery Conference states as follows.

1. On September 28, 2012, MIEC provided Ameren Missouri's counsel with Noranda Aluminum, Inc.'s 2012 budget and financial projections for the New Madrid Smelter for the years 2012 through 2015. This document is designated as Highly Confidential.
2. Noranda has prepared no budgets for the New Madrid Smelter for any years other than 2012 and has no financial projections for the New Madrid Smelter other than the financial projections provided to Ameren Missouri's counsel on September 28, 2012.




