On January 31, 2022, the Staff of the Commission (Staff) filed its position statement. On page 6, paragraph ii. (What costs should be included?), Staff’s position states: “Staff recommends that all of the expenses listed in Empire witness Tisha Sanderson’s direct workpaper titled “Wind Consistent Model” (tab F-2WindHoldo Op Inc).” The Wind Consistent Model workpaper is not included in prefiled testimony or evidence.

The Commission will direct Staff to file the above referenced workpaper.
