## ORDER DIRECTING STAFF TO FILE ITS SURREBUTTAL EMS RUN

On January 28, 2022, the Staff of the Commission (Staff), The Empire District Electric Company d/b/a Liberty, Midwest Energy Consumers Group, and Renew Missouri filed a Non-Unanimous Partial Stipulation and Agreement (Agreement) resolving some of the issues in this case. On page two, paragraph four, the Agreement states “The Signatories further agree that Staff’s EMS run included with its surrebuttal filing reflects a quantification for the items included in the Commission’s AAO issued in Case No. ER-2019-0374 through June 30, 2021.” That EMS run was not included in Staff’s surrebuttal filing.

The Commission will direct Staff to supplement its surrebutal filing by filing the above referenced EMS run.

### THE COMMISSION ORDERS THAT:

1. Staff shall file its surrebuttal EMS run no later than February 4, 2022.
2. This order is effective when issued.
