Amendment and Supplement to Application

Viva Telecom, L.L.C. (Viva), Applicant herein, by undersigned counsel, hereby files this Amendment and Supplement to Application to reflect a change in the description of the interexchange telecommunications services to be offered by Viva and to submit it's Officer's Verification of the Application. As stated on Page 2 of the Application at the end of paragraph 1, the Officer's Verification was unavailable at the time of filing. It is submitted herewith.

Also, since filing the Application herein on July 29, 2002, Viva has altered its plans for providing interexchange service in Missouri. Viva has determined that rather than offer prepaid long distance (interexchange) phone cards to end users, Viva will instead selling blocks of time to Customers who will resell the services to end users via prepaid calling cards. To effect this Amendment, the language in paragraphs 3 and 4 of the July 29 Application should be disregarded, and the following language substituted therefor:

- 3. Applicant proposes to provide interexchange telecommunications services within Missouri by selling blocks of time to Customers who will resell the services to end users via prepaid calling cards. Applicant proposes to provide service to prospective customers throughout the state of Missouri.
- 4. Viva neither owns or operates any switching, transmission or other physical facilities in the state of Missouri. In other words, Viva Telecom, L.L.C. is a non-facilities based reseller of long-distance telephone service offered by facilities-based interexchange carriers such as AT&T and MCI. Viva will obtain inbound and outbound WATS and WATS-type services from interexchange carriers that are authorized to render such service in Missouri.

These services will in turn be resold to Viva Telecom, L.L.C.'s customers who purchase blocks of interexchange calling minutes to be resold to their customers in the form of prepaid phone cards and other calling products. Service to Viva Telecom, L.L.C.'s customers will be available on a 24 hour a day 7 day a week basis.

WHEREFORE, Viva Telecom, L.L.C., respectfully submits this Amendment and Supplement to Application, and requests the Commission approve its Application for Certificate of Service Authority as amended hereby.
