SURREBUTTAL TESTIMONY OF DR. KATHRYN WOMACK MISSOURI DEPARTMENT OF CONSERVATION CASE NO. EA-2018-0202

- 1 Q. Please state your name, title and business address.
- 2 A. Kathryn Womack, Ph.D., Resource Scientist, Missouri Department of Conservation's
- 3 Agricultural Systems Field Station, 3500 S. Baltimore Street, Kirksville, MO 63501.
- 4 Q. Have you previously submitted testimony in this proceeding before the Missouri
- 5 Public Service Commission?
- 6 A. Yes. I submitted Rebuttal Testimony on August 20, 2018. My professional background
- 7 and qualifications are contained in that prior testimony.
- 8 Q. What is the purpose of your Surrebuttal Testimony?
- 9 A. My Surrebuttal Testimony is provided in response to portions of the rebuttal testimony of
- the Office of the Public Counsel ("OPC") and the Division of Energy ("DE").
- 11 Q. Do you concur with the statements regarding the natural resources (mainly bats)
- made by OPC Witness Dr. Geoff Marke?
- 13 A. Yes, I agree that Dr. Marke's assessment is accurate. I am familiar with the literature Dr.
- Marke referenced and support his conclusions. I particularly agree with the fact that bats will be
- killed by this project, it is just a matter of how many and when will these fatalities occur. Robust
- post-construction monitoring is critical at this site due to the high numbers of Indiana bats using
- the project area. There is no dispute the project area contains maternity roost trees and maternity
- colonies. The level of effort recommended, particularly with respect to mitigation (see the

- 1 recommendations in my Rebuttal testimony), would not be recommended by the Missouri
- 2 Department of Conservation ("MDC") if the project was in another region of the state.
- 3 Q. Dr. Marke commented that requiring environmental mitigation precautions on this
- 4 project would not impact future wind development in Missouri do you agree?
- 5 A. This project is in one of the worst locations in Missouri for wind development from an
- 6 endangered species perspective. Each project should be and is evaluated separately. Any project
- 7 in the same vicinity would likely require similar mitigation and monitoring. However, my pre-
- 8 construction, operational mitigation, and post-construction monitoring recommendations in my
- 9 Rebuttal testimony are project and site specific.
- 10 Q. Would you add anything to Dr. Marke's concern regarding bat species on the
- 11 project area?
- 12 A. Yes, Dr. Marke did not include any of the bat species that are state species of
- conservation concern ("SOCCs") that we have evidence occur within the project area. For this
- project site these include: tri-colored bat, silver-haired bat, little brown bat, and, pending the
- 15 Conservation Commission approval, the hoary bat. MDC is constitutionally charged with the
- 16 control, management, restoration, conservation and regulation of the bird, fish, game forestry and
- all wildlife resources of the state. These resources include SOCCs. MDC has an interest in
- managing SOCC species such that they do not result in additional listings under the federal
- 19 Endangered Species Act.
- 20 Q. Dr. Marke encouraged operational considerations to avoid taking of bats before
- violations of the Endangered Species Act occur. Do you agree with Dr. Marke and what
- 22 would you recommend?

A. Yes, Dr. Marke offers two options – operating at a cut-in speed of 6.9 m/s with post-1 2 construction monitoring or getting an incidental take permit ("ITP") from USFWS prior to operation. Additionally, I would also recommend siting turbine locations as far away from 3 known Indiana bat and northern long-eared bat maternity roosts and capture locations within the 4 project area (greater than 1000 feet). There are several bat deterrents and real-time monitoring 5 6 systems that are either being beta tested and/or developed. This project is appropriate to test one or multiple of these bat mitigation strategies as this site has multiple bat conservation concerns – 7 maternity activity (May 15- August 15) as well as a migration risk (spring and fall). 8 9 Through Ameren's response to MDC's Data Request #17, shapefiles of Indiana bat roost tree locations and turbine locations show that there are ***_____*** within 10 the Project Area, with a total of *** _____*** identified within and just outside the 11 Project Area. Data from roost trees was from *** _____*** data. This data does 12 not include capture locations for Indiana bats. However, from the provided data, there are 13 *** ____*** turbines located within *** _____*** See Figure 1. 14

- 1 Q. Dr. Marke recommends public reporting of bat mortalities, do you agree and why?
- 2 A. Yes, this reporting is necessary to determine the actual fatality rates for federally listed
- 3 bat species (Indiana bats and northern long-eared bats) and Missouri's bat SOCCs. In talking
- 4 with the U.S. Fish and Wildlife Service, it is my understanding this would be the first wind
- 5 project permitted under the Endangered Species Act in the United States with multiple known
- 6 Indiana bat maternity colonies inside the Project Area. Additionally, the data will help us

- 1 understand the status of the species. Public disclosure of the data will help the Commission, the
- 2 Company and the public balance the desire for green energy and the constitutional mandate to
- 3 restore and conserve the state's wildlife resources as more wind projects are developed. I further
- 4 agree that transparency is important to Missouri taxpayers who fund the research, management,
- 5 and recovery of the species that could be impacted by this project.
- 6 Q. Do you agree with DE Witness Mr. Hyman's recommendation that Ameren (or it's
- 7 developer) coordinate with MDC in the early stages of project development for future
- 8 energy projects?
- 9 A. Yes, coordination and the request of a Natural Heritage Database Report for the proposed
- project area would allow for MDC to better inform Ameren or Ameren's developer of any
- potential wildlife risks in the proposed project area. Proper siting of wind projects can greatly
- reduce wildlife impacts.
- 13 Q. Do you think that coordination with MDC alone is enough for this project?
- 14 A. No. Because of the importance of the region for Indiana bat maternity colonies within
- and surrounding the Project Area, coordination alone is not enough. There is also a need for
- 16 robust monitoring, recommended by MDC, to better understand the impact to the species. Robust
- monitoring should include not only post-construction mortality monitoring, but also bat
- movements and roost locations used within the Project Area, such as through radio tracking. As
- 19 fully discussed in my Rebuttal testimony, my recommendations include pre-construction
- 20 monitoring as well as recommendations to minimize, mitigate, and monitor the bat resources
- 21 during construction, post-construction, and throughout the life of the facility. The
- recommendations pertain not only to federally listed species but also to all Missouri bat SOCCs.

- 1 These monitoring results should be reported to MDC in the ordinary course through the
- 2 Wildlife Collector's Permitting process.
- 3 Q. Does this conclude your testimony?
- 4 A. Yes.
