#### STAFF'S POSITION STATEMENTS

## I. Issues List

1. Does the Commission have jurisdiction in this case?

Staff's Position: Yes.

2. Does the Commission decision consider all relevant factors?

<u>Staff's Position:</u> This is an issue posited by Ag Processing, Inc. a Cooperative and the Sedalia Industrial Energy Users' Association ("Industrial Intervenors") that Staff does not understand as the decision in question is unidentified; therefore, Staff has no position on this issue at this time.

3. Should GMO's carrying costs in the phase-in tariff schedules filed in this proceeding be 3.25% per year?

<u>Staff's position:</u> Yes, as supported by the testimony of Staff witness David Murray and KCP&L Greater Missouri Operations Company witness Kevin E. Bryant.

4. Should the Commission order that the tariff schedules filed with the Non-Unanimous Stipulation And Agreement on September 2, 2011, for the second, third and fourth year of the phase-in plan be allowed to become effective automatically in each

# subsequent year on June 25 without further order of the Commission, unless suspended by the Commission for good cause shown?
