**AMEREN MISSOURI'S MOTION
TO EXTEND FILING DATES**

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) and hereby submits its Motion to Extend the Filing Dates for Surrebuttal and Cross-Surrebuttal Testimony; the List of Issues, Order of Cross-Examination, and Order of Opening Statements; and Position Statements, stating:

1. Following the prehearing conference held in this case, a Jointly Proposed Procedural Schedule was filed on March 29, 2012.
2. The Commission adopted the jointly proposed procedural schedule in an order issued on March 30, 2012.
3. On April 12, 2012, the Staff of the Commission filed a Motion to Modify Procedural Schedule, asking that the hearing be moved back one week and the briefing schedule be modified to accommodate a conflict of one of its witnesses. No party objected to Staff's motion.
4. On April 13, 2012, the Commission granted the Staff's Motion to Modify Procedural Schedule.
5. Due to conflicts experienced by its own witnesses, Ameren Missouri is asking the Commission to further modify the procedural schedule to delay the date Surrebuttal and Cross-Surrebuttal Testimony is due by one week as well. Specifically, the Company is requesting that the Commission adopt the following revised due dates to accommodate this request:
