**FILING MEMORANDUM**

COMES NOW Atmos Energy Corporation ("Atmos"), and pursuant to 4 CSR 240-2.080 and in response to the Joint Procedural Schedule And Joint Motion Requesting Adoption Of Certain Other Procedural Matters filed on February 2, 2010, respectfully states as follows:

1. On February 2, 2010, the Staff filed a Joint Procedural Schedule And Joint Motion Requesting Adoption Of Certain Other Procedural Matters ("Procedural Schedule Motion") on behalf of itself and other parties to this proceeding. In paragraph 7 of the Procedural Schedule Motion, it stated: "The parties also propose that Atmos will separately notify customers subject to reclassification in the small general service class and medium general service class of their expected rate impacts, and that Atmos will submit that notice for Commission approval no later than February 5, 2010."

2. In response to this provision of the Procedural Schedule Motion, Atmos has prepared the attached Notices Of Requested Rate Increase And Request For Public Comment for approval by the Commission. Atmos proposes to send these customer notices to individual Small General Service and Medium General Service customers that are subject to the Company's proposal to reclassify these classes of service by a separate mailing.

**WHEREFORE**, in response to the Procedural Schedule Motion filed on February 2, 2010, Atmos Energy Corporation files the attached Customer Notices for approval by the

Commission, and respectfully requests that the Customer Notices be approved by the Commission.
