ORDER DIRECTING LIBERTY RESPONSE

On January 25, 2022, The Empire District Electric Company d/b/a filed a motion and request for expedited treatment for the Commission to acknowledge that it has removed issues related to Winter Storm Uri and the Asbury generation plant from this general rate case. Liberty states it will be seeking to securitize those costs in lieu of seeking rate case recovery. On January 31, 2022, Liberty filed a motion renewing its request.

The Commission has questions concerning Liberty's request. The Securitization Statute, Section 393.1700, does not appear to have any mechanism to net revenues or overearnings from a securitization request. Liberty has been earning a return on and of Asbury since its last rate case. Liberty states it has removed "all components of the revenue requirement relating to the Asbury generating unit."

Charlotte Emery's surrebutal testimony contains the following chart of pro-forma adjustments to remove Asbury from the cost of service:
