ORDER GRANTING STAFF'S MOTION TO MODIFY ORDER AND
ORDER ESTABLISHING PREHEARING CONFERENCE

On June 30, 2006 Ozark Energy Partners, LLC filed an application as described in the above caption. On July 5, the Missouri Public Service Commission issued an order directing the Staff of the Commission to file its memorandum in this matter no later than September 5, 2006. On August 11, Staff filed a motion to modify the Commission's order.

In its motion, Staff points out that Ozark's application does not include necessary information. Without such information, Staff is unable to make an informed recommendation to the Commission. Staff therefore requests that the Commission modify its order to relieve Staff of having to file its memorandum on September 5. Rather, Staff suggests that the Commission set this matter for a prehearing conference to afford the parties an opportunity to explore a resolution of this case. On August 21, 2006, Ozark filed a pleading stating that it is not opposed to Staff's motion.

The Commission has review Staff's motion and finding it reasonable will grant the requested relief.

IT IS ORDERED THAT:

1. The Staff of the Commission's motion to modify the Commission's order of July 5, 2006, is granted.
2. The Staff of the Commission need not file its memorandum in this matter on September 5, 2006.
3. A prehearing conference shall be held on September 12, 2006, beginning at 10:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. 4. This order shall become effective on September 1, 2006.
