There is no other income, expenses, etc...in any of these entities other than that which flows through SMNG. Therefore, SMNG's financial statements represent the financials of all these entities.

There are no corporate allocations from any of the ownership entities or other companies. Sendero Asset Management, LLC (SAM) has a Management Agreement with SMNG which was reviewed by the MPSC at the time of SMNG's acquisition which provides for a specific monthly fee plus reimbursement of direct expenses. SAM does not own any interest in SMNG.

All of SMNG's financings were secured by the assets of SMNG and are non-recourse to any/all entities other than SMNG.
