NOTICE OF DISMISSAL

On February 8, 2018, Summit Natural Gas of Missouri, Inc. ("Summit") filed an application with the Missouri Public Service Commission requesting a certificate of convenience and necessity to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Daviess County, Missouri. On June 28, 2018, Summit filed a notice with the Commission voluntarily dismissing its application.

Commission Rule 4 CSR 240-2.116(1) states that an applicant may dismiss an application without an order of the Commission before prepared testimony or oral evidence has been offered. The parties have not offered prepared testimony or oral evidence. The Commission, therefore, will take notice of Summit's dismissal. This case shall be closed.
