## ORDER GRANTING REQUEST FOR EXTENSION OF TIME TO RESPOND TO STAFF RECOMMENDATION

On May 22, 2018, the Commission's Staff filed a report and recommendation regarding Summit Natural Gas of Missouri, Inc.'s ("Summit") application for a certificate of convenience and necessity. On May 31, 2018, Summit filed a request for an extension of time until June 21, 2018 to respond to Staff's recommendation. Summit believes it would be beneficial to have additional time to discuss this matter with Staff and provide more documentation. The Commission finds the request reasonable and will grant the request.

### THE COMMISSION ORDERS THAT:

1. Summit Natural Gas of Missouri, Inc.'s request for an extension of time filed on May 31, 2018, is granted. The deadline for responding to Staff's recommendation is extended until no later than June 21, 2018.
