## ORDER GRANTING APPLICATIONS TO INTERVENE

On October 31, 2017, The Empire District Electric Company applied to the Commission for approval of its proposed plan to achieve customer savings through the development of wind generation using federal tax incentives in conjunction with a tax equity partner and the retirement of a coal-fired unit. On November 1, 2017, the Commission issued an order directing notice of the application and setting a deadline of November 22, 2017 for persons requesting to intervene in this matter.
