



3. The Company is affiliated with CoBridge Telecom, LLC d/b/a Fidelity Communications (“COT”), which holds authority to provide video service in Missouri (ID 4490), and with CoBridge Broadband, LLC d/b/a Fidelity Communications (“COB”), which holds authority to provide video service in Missouri (ID 4491). Pursuant to the Transaction, Cable One also acquired one hundred percent (100%) ultimate ownership and control of COT and COB.

4. Cable One is a publicly traded Delaware corporation with headquarters located at 210 E. Earll Drive, Phoenix, Arizona 85012. Cable One and its subsidiaries provide video, Internet access, and voice services in 21 states, including Missouri. In Missouri, Cable One holds authority to provide video service (ID 3835) and is registered as an interconnected Voice over Internet Protocol (“IVoIP”) service provider (ID 6833). Cable One’s subsidiary, Telecommunications Management, LLC d/b/a NewWave Communications (“NewWave”), also holds authority to provide video service (ID 5138) and is registered as an IVoIP service provider (ID 7047) in Missouri. Finally, Cable One’s subsidiary, Delta Communications, L.L.C. d/b/a Clearwave Communications (“Clearwave”) holds authority to provide competitive local exchange and interexchange services in Missouri (IDs 3373 and 1323).

5. Immediately prior to the close of the Transaction, the Company was converted from a Missouri corporation to a Missouri limited liability company (“LLC”).

6. All Commission records should be updated to reflect the Company’s new name as Fidelity Cablevision, LLC.

7. The Transaction and the LLC conversion were transparent to the customers of the Company. There was no change in service provider from the customer’s

perspective. Customers will continue to receive service from “Fidelity Communications” and all billing and correspondence will continue to be provided by Fidelity Communications for the immediate future.

WHEREFORE, the Company requests that the Commission accept this notice of transfer of video service authorization pursuant to 67.2701 RSMO.
