On October 30, 2017, the Macon Electric Cooperative and the City of Marceline filed an application with the Missouri Public Service Commission requesting a change of electric suppliers for sixteen current City of Marceline electric customers and property owners. The applicants explain that these customers consent to the change of supplier and that the change is in the public interest as it will ensure reliable service, enhance operational efficiencies, and reduce utility duplication. The Commission will direct its Data Center to send this notice to the property owners. The Commission will also direct the Staff of the Missouri Public Service Commission to file a recommendation.

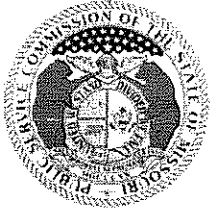
### THE COMMISSION ORDERS THAT:

1. The Data Center of the Missouri Public Service Commission shall send a copy of this notice to the property owners involved; as enumerated in Appendix B of the application.
2. The Staff of the Missouri Public Service Commission shall file a recommendation or a status report indicating when it will file its recommendation no later than November 30, 2017.

3. Any other person wishing to file a response to this application shall do so no later than November 30, 2017.

4. This order shall be effective when issued.




