ORDER SETTING ADDITIONAL LOCAL PUBLIC HEARINGS

On November 16, 2006, the Commission issued an order scheduling local public hearings in Lee's Summit and St. Joseph, Missouri. After further considering this matter, the Commission has decided that two additional local public hearings are appropriate to better reach Aquila, Inc.'s customers throughout its service territory. For that reason, the Commission will schedule additional local public hearings in Sedalia and Nevada, Missouri. Aquila shall amend the notice sent to its customers to include notice of these additional hearings.

IT IS ORDERED THAT:

1. The Commission shall hold a local public hearing on Tuesday, January 23, 2007, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, at State Fair Community College, Multi-Purpose Building #219, 3201 West 16th Street, Sedalia, Missouri.

2. The Commission shall hold a local public hearing on Tuesday, January 23,

2007, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so,

whichever is sooner, at Nevada Telecenter/University of Missouri Extension, 2015 N. West

Street, Nevada, Missouri.

3. No later than ten days before the local public hearings, Aquila, Inc., shall

provide individual notice to each of its electric service customers including the notice as set

out below.

NOTICE

Aquila, Inc., doing business as Aquila Networks – MPS and as Aquila Networks – L&P, has filed revised electric tariff sheets with the Missouri Public Service Commission (PSC) that would increase the company's Missouri jurisdictional annual gross revenues in its MPS service area by approximately \$94.5 million and in its L&P service area by approximately \$24.4 million. For the average MPS residential customer using 1,000 kilowatt hours of electricity, the proposed increase would be approximately \$21.19 each month. For the average L&P residential customer using 1,000 kilowatt hours of electricity, the proposed increase would be approximately \$16.09 each month. The proposed increase is approximately 22% in each of the company's service territories.

Aquila, Inc.'s rate filing includes a request to implement a fuel adjustment clause. A fuel adjustment clause, if approved by the Commission, would allow increases or decreases in fuel and purchased power costs occurring after base electric rates are set by the pending electric rate case to be passed through to customers as a separate line on customer's bills. Increases in fuel and purchased power costs above base electric rates would be applied to customer bills via a separate and additional charge and decreases would be applied to customer bills via a credit.

Public comment hearings have been set before the PSC as follows:

- Tuesday, January 23, 2007, from 6:00 p.m. to 9:00 p.m. at Nevada Telecenter/University of Missouri Extension, 2015 N. West Street, Nevada, Missouri.
- Wednesday, January 24, 2007, from 6:00 p.m. to 9:00 p.m., at Hillyard Technical Center, ITV Room, 3434 Faraon, St. Joseph, Missouri.

*A question-and-answer session will be held one-half hour before the beginning of each hearing.

The Commission will also conduct an evidentiary hearing at its offices in Jefferson City during the weeks of April 2 through 6, and April 9 through 13, 2007, beginning at 8:30 a.m.

The hearings and local public hearings will be held in buildings that meet accessibility standards required by the Americans with Disabilities Act. send a copy of this order to members of the General Assembly and to the media that serve

Aquila, Inc.'s service area.

7. Aquila, Inc., shall place advertisements in the newspapers serving its service territory. The advertisements shall contain the information from the customer notice relevant to the customers in the newspaper's circulation area.

8. This order shall become effective on November 21, 2006.
