AFFIDAVIT

I am Mr. Ed Musser of Jefferson City, Missouri. I am employed by Cable TV and I work out of Cable TV's office at 1419 Missouri Blvd., Jefferson City, Missouri. I am the microwave engineer for Cable TV, and it is my responsibility to service various microwave stations which Cable TV maintains and operates in mid-Missouri. In addition to the station here at Jefferson City, I am responsible for servicing these microwave stations in Moberly, Slater, Fayette, Columbia, Fulton, and in Montgomery County. It is absolutely essential that I be reached quickly 24 hours a day in my work. If there is a malfunction at one of these stations, I must be able to know about it immediately. At the present time, I use a pager provided by Mid-Missouri Emergency Association, through the facilities of its agent, Control Center, Inc. of Jefferson City, Missouri. In addition to myself, there are three other key personnel of Cable TV who use pagers also, as it is necessary in their duties.

We feel there is a real need for this type of paging service in the Jefferson City area, and we are supporting the application of Control Center, Inc. which is pending before the Missouri Public Service Commission.

My name is Ron Boyce, of Boyce & Schrimpf, Inc., 409 W. Elm, Jefferson City, Missouri. My firm is engaged in the plumbing, heating, and air conditioning business in the mid-Missouri area.

We have several crews working in different locations at the same time. It is necessary that these crews be able to reach me at all times as there are decisions on materials and work that must be made without returning to our shop. It is also essential that our customers who need servicing on their equipment be able to reach me at any time no matter where I may be working at that particular time.

These are the reasons why we have found the paging service we subscribe to through Mid-Missouri Emergency Association so invaluable in our business. We feel there is a real public need for this type of paging service in the Jefferson City area, and we are supporting Control Center, Inc.'s application before the Missouri Public Service Commission in its efforts to obtain a certificate so it can do the paging service on its own.




