SECTION 1.0-DEFINITIONS

For the purpose of this tariff, the following definitions will apply:

Access Service Request: The written request for access service executed by the Customer and the Company in the format devised by the Company. The signing of an Access Service Request by the Customer and acceptance by the Company initiates the respective obligations of the parties as set forth therein and pursuant to this Tariff, but the duration of the service is calculated from the Service Commencement Date. Any use of the Company's access service at any time without an executed Access Service Request is subject to the obligations, rates and charges as set forth in this Tariff (the Company may request such a Customer to submit an Access Service Request).

Advance Payment: Part or all of a payment required before the start of service.

<u>Automatic Number Identification ("ANI")</u>: Allows the automatic transmission of a caller's billing account telephone number to a local exchange company, interexchange carrier or a third party Customer. The primary purpose of ANI is to allow for billing of toll calls.

<u>Collocation</u>: An arrangement whereby the Company's switching equipment is located in a local exchange Company's central office.

Company or Carrier: Refers to Big River Telephone Company, LLC, issuer of this tariff.

<u>Customer or Customer</u>: The person, firm or corporation which orders service and is responsible for the payment of charges and compliance with the Company's regulations.

Deposit: Refers to a cash or equivalent of cash security held as a guarantee for payment of the charges.

<u>DID Trunk</u>: A form of local switched access that provides the ability for an outside party to call an internal extension directly without the intervention of the Company operator.

<u>Direct Inward Dial (or "DID")</u>: A service attribute that routes incoming calls directly to stations, by-passing a central answering point.

<u>Direct Outward Dial (or "DOD")</u>: A service attribute that allows individual station users to access and dial outside numbers directly.

<u>End Office</u>: With respect to each NPA-NXX code prefix assigned to the Company, the location of the Company's "end office" for purposes of this tariff shall be the point of interconnection associated with that NPA-NXX code in the Local Exchange Routing Guide ("LERG"), issued by Bellcore.

Exchange Telephone Company or Telephone Company: Denotes any individual, partnership, association, joint-stock company, trust, or corporation authorized by the appropriate regulatory bodies to engage in providing public switched communication service throughout an exchange area, and between exchange areas within the LATA.

<u>Hearing Impaired</u>: Those persons with communication impairments, including those hearing impaired, deaf, deaf/blind, and speech impaired persons who have an impairment that prevents them from communicating over the telephone without the aid of a telecommunications device for the deaf.

Hunting: Routes a call to an idle station line in a prearranged group when the called station line is busy.

IXC or Interexchange Carrier: A long distance telecommunications services provider.

<u>LATA</u>: A Local Access and Transport Area established pursuant to the Modification of Final Judgment entered by the United States District Court for the District of Columbia in Civil Action No. 82-0192; or any other geographic area designated as a LATA in the National Exchange Carrier Association, Inc. Tariff F.C.C. No. 4.

<u>LDD</u>: LDD, Inc., the original issuer of this tariff, now Big River by adoption.

<u>Monthly Recurring Charges</u>: The monthly charges to the Customer for services, facilities and equipment, which continue for the agreed upon duration of the service.

<u>Multiline</u>: An individual flat rate exchange service furnished by means of two or more exchange lines terminating in apparatus which facilities pick-up by associated stations. Multiline rates do not apply where the PBX trunk rate applies or to Centrex Service.

Nonrecurrine Charge ("NRC"): The initial charge, usually assessed on a one-time basis, to initiate and establish service.

NPA: Numbering plan area or area code.

PBX: Private Branch Exchange.

Point of Presence ("POP"): Point of Presence.

<u>Recurring Charges</u>: The monthly charges to the Customer for services, facilities and equipment which continue for the agreed upon duration of the service.

SWBT: Refers to Southwestern Bell Telephone LP, dba AT&T Missouri.

<u>Service Order</u>: The written request for Network Services executed by the Customer and the Company in the format devised by the Company. Shared: A facility or equipment system or subsystem that can be used simultaneously by several Customers.

<u>Toll Free</u>: A term used to describe the service formerly known as 800 Service. Toll Free Service provides incoming service utilizing 800, 888 and other 8XX numbers.

<u>Two Wav</u>: A service attribute that includes outward dial capabilities for outbound calls and can also be used to carry inbound calls to a central point for further processing.

<u>Usage Based Charges</u>: Charges for minutes or messages traversing over local exchange facilities.

<u>User or End User</u>: A Customer, Joint User, or any other person authorized by a Customer to use service provided under this tariff.

- .2 Basic local telecommunications service may not be discontinued for customer nonpayment of a delinquent charge for other than basic local telecommunications services. The failure to pay charges not subject to commission jurisdiction shall not constitute cause for a discontinuance of basic local telecommunications service. Nonpayment of the Missouri Universal Service Fund (USF) surcharge shall be considered nonpayment of basic local telecommunications services for purposes of this section.

- Notwithstanding any other provision of this tariff, the Company will postpone a discontinuance for at least twenty-one (21) days if the service is necessary to obtain emergency medical assistance for a person who is a member of the household where the service is provided and where such a person is under the care of a physician. 

Non-recurring charges apply to processing Service Orders for new service, for changes in service, and for changes in the Customer's primary interexchange carrier (PIC) code.

#### 4.1.1 Service and Equipment Charge

The Service and Equipment Charge is a nonrecurring charge associated with a given service which applies each time the service is provided. Where two or more of the Service and Equipment Charges listed below would occur on the same exchange access line on the same order, only one Service and Equipment Charge - the highest of the charges that would otherwise apply - is applied. Service and Equipment Charges are associated with the following:

- Exchange access line
- Temporary suspension of service at the Customer's request
- Restoral of service after a temporary denial for nonpayment

Service and Equipment Charges, where applicable are specified in this Tariff in the appropriate section for a given service.

#### 4.1.2 Moves

When at the request of the Customer, the network facilities are required to be moved for a Customer-Provided Communications System, PBX, or key system, this move will be based on the cost of making the change.

#### 4.1.3 Restoration of Service

A Service and Equipment Charge will apply for restoring service after it is temporarily suspended by the Company. This charge applies only after the suspension of service and not after the completion of a disconnection order. In addition to this charge, the Customer will be required to pay all charges due, including the charges for the period of denial.

#### 5.3 Distance Calculations

Where charges for a service are specified based upon distance, the following rules apply:

- 5.3.1 Distance between two points is measured as airline distance between the rate centers of the originating and terminating telephone lines. The rate center is a set of geographic coordinates, as referenced in Local Exchange Routing Guide issued by Bellcore, associated with each NPA-NXX combination (where NPA is the area code and NXX is the first three digits of a seven-digit telephone number). Where there is no telephone number associated with an access line on the Company's network (such as a dedicated 800 or WATS access line), the Company will apply the rate center of the Customer's main billing telephone number.
- 5.3.2 The airline distance between any two rate centers is determined as follows:
  - Step 1: Obtain the "V" (vertical) and "H" (horizontal) coordinates for each Rate Center from the above-referenced Bellcore document.
  - Step 2: Compute the difference between the "V" coordinates of the two rate centers; and the difference between the two "H" coordinates.
  - Step 3: Square each difference obtained in step (b) above.
  - Step 4: Add the square of the "V" difference and the square of the "H" difference obtained in step C) above.
  - Step 5: Divide the sum of the squares by 10. Round to the next higher whole number if any fraction is obtained.
  - Step 6: Obtain the square root of the whole number result obtained above. Round to the next higher whole number if any fraction is obtained. This is the airline mileage.

#### 5.5 Basic Local Exchange Service

Basic Local Exchange Service provides the Customer with a single, analog, voice-grade telephonic communications channel which can be used to place or receive one call at a time. Basic Local Exchange Service lines are provided for the connection of Customer-provided wiring, telephones, facsimile machines or other station equipment. An optional per line Hunting feature is available for multi-line Customers which routes a call to the next idle line in a prearranged group when the called line is busy.

Local exchange service lines and trunks are provided on a single party (individual) basis only. No multi-party lines are provided. Service is available on a flat rate or message rate basis depending on the service plan selected by the Customer. Not all service plans will be available in all areas. Recurring charges are billed monthly in advance. Usage charges, if applicable are billed in arrears. Basic local exchange service is not offered on a la carte basis when the service is provided using the underlying switching services of another communications carrier, i.e. using Resale or Local Wholesale Complete services. For customers desiring local exchange service and the service is provided using the underlying switching services of another communications carrier, those customers can obtain local exchange services as part of Big River's Residential Saving Package outlined in Section 5.18.

Usage charges may apply for calls placed from the Customer's line. No usage charges will apply to calls received by the Customer. Non-recurring charges for installation or rearrangement of service are billed on the next month's bill immediately following work performed by the Company. Rates and charges include Touchtone service for each line.

#### 5.5.1 Rate Groups

Exchange rates are divided by Rate Groups. The number of exchange access arrangements included within the primary service area of each exchange or zone determines the Rate Group and rates for each exchange or zone.

#### 5.10 Residence and Business PBX Trunk Service

PBX Trunk service provides a Customer with a single, voice-grade telephonic communications channel which can be used to place or receive one call at a time. Trunks are provided for connection of Customer-provided private branch exchanges (PBX) or other station equipment to the public switched telecommunications network. PBX Trunks are available to Business and Residence Customers as Inward, Outward or Two-Way combination trunks where services and facilities permit.

Each PBX Trunk is provided with touch tone signaling at no additional charge. An optional per trunk Hunting feature is available for Customers which routes a call to the next idle trunk in a prearranged group.

PBX Trunks may also be equipped with Direct Inward Dialing (DID) capability and DID number blocks for additional charges.

#### 5.11 Direct Inward Dialing (DID) Service

MO. PUBLIC SERVICE COMM

Direct Inward Dialing ("DID") permits calls incoming to a PBX system or other Customer Premises Equipment to be routed to a specific station without the assistance of an attendant. DID calls are routed directly to the station associated with the called number. DID service as offered by the Company provides the necessary trunks, telephone numbers, and out-pulsing of digits to enable DID service at a Customer's location. DID service requires special PBX software and hardware not provided by the Company. Such hardware and software is the responsibility of the Customer.

DID numbers are provided on a consecutive-number basis.

Rates and charges for DID numbers apply on a per trunk group basis. The rate and charge for an initial block of DID numbers, whether in quantities of 100 or in quantities of 10, will apply once for each quantity. All subsequent number blocks will be at the rates and charges specified for additional quantities.



The features in this section are made available on an individual basis or as part of multiple feature packages. All features are provided subject to availability. Certain features may not be available with all classes of service. Transmission levels for calls forwarded or calls placed or received using optional calling features may not be acceptable for all some uses in some cases.

#### 5.12.1 Feature Descriptions

- .1 Call Waiting Alerts a Customer using his telephone that another caller is trying to reach him. Where facilities permit, Call Waiting subscribers may deactivate Call Waiting for the duration of one call by dialing a code. Call Waiting is automatically reactivated for the next originating or terminating call.

The 8-code capacity and/or the 30-code capacity may be provided on the same line, however, duplicate code capacities may not be provided. The combination of code capacities is not available on multiline hunting lines.
- .5 <u>Call Return</u> Enables the Customer to automatically redial the telephone number of the last incoming call. If that telephone number is busy, the Company's equipment will keep trying to call the number being redialed for a maximum of thirty(30) minutes. The Customer will be signaled with a distinctive ring when the call can be completed.
- .6 <u>Auto Redial</u> Enables the Customer to automatically redial the last outgoing telephone number. When the recalled telephone number is busy, the Company's equipment will keep trying to call the number being redialed for a maximum of thirty (30) minutes. The Customer will be signaled with a distinctive ring when the call can be completed.

- .7 Priority Call Provides the Customer with a distinctive ring or Call Waiting tone (if the Customer has subscribed to Call Waiting), when the Customer is called form preselected telephone numbers. The Customer can construct or modify the telephone number screening list by dialing a unique code.
- .8 <u>Call Blocker</u> Enables the Customer to block calls from preselected telephone numbers and/or the last incoming call (without knowing the number). To block specified telephone numbers, the Customer builds a screening list. To block an unknown number after receiving a call, the Customer enters a code to add the number to their screening list. Customers whose telephone numbers are blocked are directed to a Company recorded announcement.

- .15 Remote Access to Call Forwarding Provides a Customer that also subscribes to Call Forwarding service the ability to activate, deactivate or change the Call Forwarding feature from a remote location by dialing a Company provided remote access number. This feature can only be activated by using a Dual Tone Multi-Frequency (DTMF) telephone which has a full set of characters, including "\*" and "#". Any charges incurred in accessing the remote number will be billed as appropriate.

#### 5.12.2 Regulations

- Per line blocking for the blocking of CPN will be available upon request, at no .1 charge, to the following entities for lines over which the official business of the agency is conducted, including those at the residences of employees/volunteers, where an executive officer of the agency registers a need for blocking and provides the required certification to the Company: a)private, nonprofit, tax exempt, domestic violence intervention agencies and b)federal, state, and local law enforcement agencies. The CPN will not be transmitted from a line equipped with this capability. Per line blocking is operational on a continuous basis but can be deactivated by the Customer by dialing an access code immediately prior to placing a call. Line blocking Customers can unblock their CPN information on a per call basis, at no charge, by dialing an access code immediately prior to placing a call.
- .2 A Customer may prevent the delivery of their calling name and/or number to the called party by dialing an access code immediately prior to placing a call. The access code will activate per call blocking, which is available at no charge. If the calling party activates blocking, the CPN will not be transmitted across the line to the called party. Instead, Calling Line Identification Customers will receive an anonymous indicator. This anonymous indicator notifies the Caller ID Customer that the calling party has elected to block the delivery of their name telephone number. The blocking of CPN will not be provided on calls originating from Customer Owned Pay Telephones. If the Caller ID Customer also subscribes to Anonymous Call Rejection, the calling party will be routed to a telephone company recording advising the caller that the called party will not accept calls whose CPN

Customers are provided with a maximum of two (2) listings per each call to Directory Assistance. A Directory Assistance charge applies per local directory assistance call subject to the allowances listed below.

Information for nonpublished Customers will not be provided. Each request for listing information is considered one listing request. Listing request allowances do not apply for requests of listing information when that information is available in a current white page Directory or for calls to intraLATA Directory Assistance (1-NPA-555-1212) where the NPA is the same as the NPA from where the call is originated.

Allowances for listing requests apply only:

- to sent-paid direct dialed calls to Directory Assistance. These calls will be allowed a maximum of two listing requests per call.
- when the listing is new and not printed in the most recent white pages Directory, or
  when the listing is not found by the Directory Assistance Operator. Nonpublished
  and nonlisted telephone number requests will not be given and do not count toward
  a Customer's allowance.

Fully-Automated DACC - The Customer receives the requested directory number from the automated system and accepts DACC by pressing the designated key from a Touch-Tone telephone during the DACC announcement. The call completes without operator intervention for completion or billing assistance.

Semi-Automated DACC - The Customer receives the requested directory number from the automated system or verbally from the operator. The Customer may request DACC by either allowing the automated system to time-out back to the operator to provide call completion or the operator completes the call following the verbal report.

The Telephone Company does not obligate itself to furnish these services, particularly when it involves undue expense or impairment of the service furnished the general public.
- **7.2.3** These services are available only in connection with One-Party Line, Multiline or Private Branch Exchange Service.
- **7.2.4** Exchange Service and extensions are furnished subject to the exchange charges, rules and regulations of the foreign serving office or foreign exchange from which they are furnished. All other services and equipment are subject to the charges, rules and regulations of the exchange in which the termination is located.

### **7.2.5** RATES

- **7.2.5.1** Foreign Exchange Service will be provided for a monthly rate of \$4.00 per line. This is in addition to the charges for exchange services and extensions as outlined in 7.2.4.
- **7.2.5.2** For Foreign Exchange Service where the foreign exchange is included in a mandatory extended service area (as outlined in Paragraph 3.3) for the exchange in which the customer is located, there will be no monthly charge for the Foreign Exchange Service.
