# STAFF'S RECOMMENDATION AND MEMORANDUM REGARDING AMEREN MISSOURI'S COMPLIANCE TARIFFS

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Recommendation and Memorandum Regarding Ameren Missouri's Compliance Tariffs,* states as follows:

1. This matter commenced on February 3, 2012, when the Union Electric Company, doing business as Ameren Missouri, filed proposed tariffs providing for a general rate increase, Tariff File No. YE-2012-0370.

2. On December 12, 2012, the Commission issued its *Report & Order,* effective December 22, 2012, rejecting Ameren Missouri's proposed tariff sheets referred to above and directing the Company to file its compliance tariff not later than December 18, 2012.

3. On December 17, 2012, Ameren Missouri filed the compliance tariff required by the *Report & Order* referred to above, Tariff File No. YE-2013-0269.

4. Also on December 17, 2012, the Commission directed its Staff to review Ameren Missouri's compliance tariffs and to file a recommendation not later than December 24, 2012.

5. Attached hereto as Exhibit A is Staff's *Recommendation and Memorandum* wherein Staff states that it has examined Ameren Missouri's

compliance tariffs and determined that the same are indeed compliant with the Commission's *Report & Order* referred to in Paragraph 2, above, and should therefore be **APPROVED** for service rendered on and after January 2, 2013.

6. Staff states that there is good cause such that Ameren Missouri's compliance tariffs should be approved on less than thirty days' notice because the Commission's decision of December 12, 2012, determined that Ameren Missouri's rates are no longer just and reasonable and that a general rate increase is appropriate.

WHEREFORE, Staff urges the Commission to approve Ameren Missouri's compliance tariffs, Tariff File No. YE-2013-0269, for service rendered on and after January 2, 2013.

On December 12, 2012, the Missouri Public Service Commission (Commission) issued its Report and Order (Order) in Case No. ER-2012-0166, the Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) electric case. This Order approved an increase in the Company's overall Missouri jurisdictional gross annual electric revenues of \$260.2 million.

The Company filed tariff sheets on December 17, 2012, to comply with the Order. In its letter of transmittal accompanying the December 17, 2012, compliance filing, Ameren Missouri requested expedited treatment to reflect an effective date of January 2, 2013, which would be less than the standard 30-day period, but which complies with the Commission's suspension of Ameren Missouri's original tariff filing in this case.

The Commission's Energy Unit - Tariffs/Rate Design, Economic Analysis and Energy Resource Analysis Staff (Staff) has reviewed the tariff sheets as filed by Ameren Missouri on December 17, 2012, and is of the opinion that these sheets are in compliance with the Commission's Order. Staff is also of the opinion that good cause for approval of these tariff sheets on less than thirty days notice is demonstrated by the Commission's Order Directing Staff to File Expedited Recommendation and Establishing Time for Other Parties to Offer Recommendations. Therefore, Staff recommends the following tariff sheets filed on December 17, 2012, be approved:
