AFFIDAVIT OF DANIEL WALTERS

Daniel Walters, being first duly sworn before the undersigned Notary, hereby states upon oath and affirmation that the following statements are true and correct to the best of his knowledge, information, and belief:

- 1. My name is Dan Walters, and I reside in Bellville, Texas. I am an individual over the age of eighteen. I have personal knowledge of the facts and statements set forth in this Affidavit.
- 2. I am employed by Contract Land Staff as Land Representative. I am familiar with the Complaint filed on June 22, 2020 with the Missouri Public Service Commission, Case No. EC-2020-0408, by the Missouri Landowners Alliance, Gary Mareschal, and Marvin Daniels.
- 3. On June 9, 2020, at approximately 5:29 pm CDT, I telephoned Marvin Daniels, introduced myself by name, and asked Mr. Daniels if he had received the letter from Contract Land Staff about the Grain Belt Express transmission line project within the last few days. Mr. Daniels indicated that he had not received any letter regarding the project. I asked Mr. Daniels to verify that his address is 12194 Claremont, Wright City, MO 63390, and he verified this to be his correct mailing address.
- 4. I requested that Mr. Daniels let me know if the letter was not received within the next several days and that, if not, a new letter would be sent to him. I explained that I would be the land representative working with him for the project and asked if he had any questions regarding the project. I also indicated to Mr. Daniels that we would be requesting survey access to his property, and Mr. Daniels noted that he objected to anyone from Invenergy, Contract Land Staff, or anyone else associated with the Grain Belt Express Project being on his property until there was an agreement for them to do so. I told Mr. Daniels that no one would access his property at this time without permission. Mr. Daniels had several questions regarding the current planned route of the line, which I answered to the best of my ability.
- 5. At no point during this telephone call with Mr. Daniels did I state that "Grain Belt is no longer involved with this business", "Grain Belt is no longer involved with the business" or any other statement that could be construed as such.
- 6. On June 17, 2020, at approximately 1:28 pm CDT, I telephoned Gary Mareschal, introduced myself by name, and indicated that I was with Contract Land Staff representing the Grain Belt Express transmission line project.
- 7. I asked Mr. Mareschal if he had received the letter regarding the transmission line project from Contract Land Staff dated within the week or so prior to the phone call. Mr. Mareschal indicated that he had received the letter and that he was unwilling to sign anything or permit anyone with Grain Belt on his property. I indicated to Mr. Mareschal that I was requesting permission for survey access, and Mr. Mareschal again indicated that no one was to be allowed on his property for any reason. I thanked him for taking my call and the call was ended.

8. At no point during this telephone call with Mr. Mareschal did I state that "Grain Belt is no longer involved with this business", "Grain Belt is no longer involved with the business" or any other statement that could be construed as such.
